No fee adjustments shall be made for time lost due to late arrival by the Tutee or non-attendance.

The Tutor reserves the right to terminate the agreement following persistent late payments or absence.

### Cancellation

The agreement for weekly term-time tuition is by reference to Plymouth City Council's term dates. Therefore, should you wish to cancel, the agreement will terminate at the end of the current school term. It is not possible to end the agreement "mid-term".
